

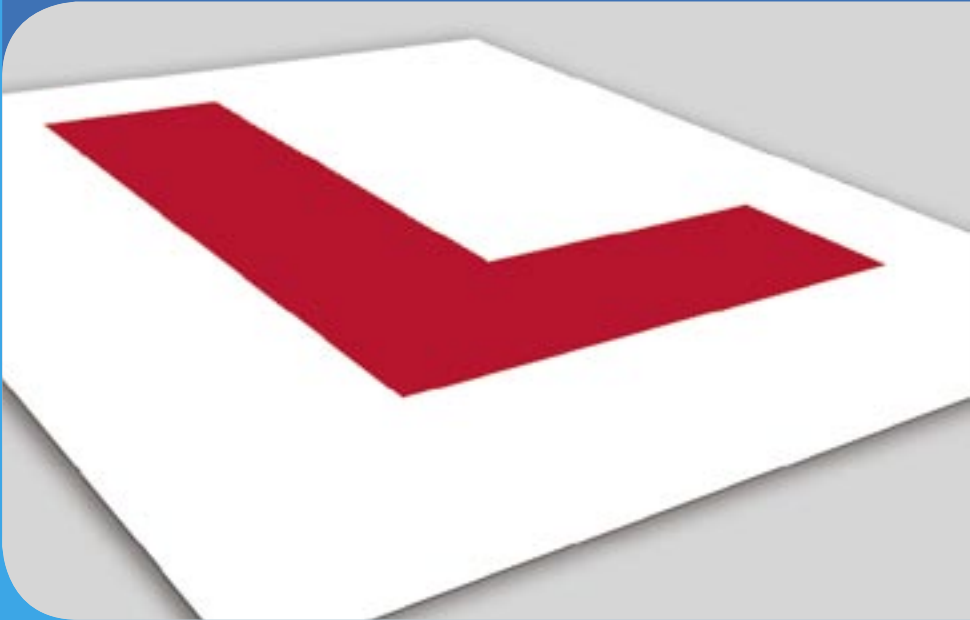

1. Introduction

This Information Leaflet explains the minimum requirements for vehicles that must be used by candidates for driving tests.

These requirements are set out in the Second EC Directive on the Driving Licence (91/439/EEC) and in The Motor Vehicles (Driving Licences) (Amendment) (No2) Regulations 1999. They apply to all the countries within the European Union, harmonising licensing and testing standards.

Throughout this leaflet reference is made to the maximum authorised mass (MAM) of vehicles and trailers. This should be taken to mean the permissible maximum weight, also known as gross vehicle weight.

All test vehicles and vehicle combinations must be unladen except for fixed items that are characteristic of the category of vehicle to which it belongs.

All vehicle combinations used for tests in categories B+E, C1+E, D1+E, C+E and D+E must be equipped with suitable coupling and braking systems designed for use when the trailer is fully laden.

In addition, vehicles used for all types of D category test must normally allow the examiner to see the road behind the vehicle clearly from the deck on which the driver is seated without using any optical aid.



2. Minimum test vehicles from 1 January 1997

Category of Vehicle	Minimum Test Entitlement
A1	A solo motorcycle between 75cc and 125cc and power output not exceeding 11kW (14.6 bhp)
A	A solo motorcycle over 120cc but not more than 125cc, capable of 100kph. A test pass on a motorcycle meeting this specification restricts entitlement to riding a motorcycle with a power output not exceeding 25kW (33bhp) for two years. For those aged 21 or over a test may be taken on a solo motorcycle with a power output of at least 35kW (46.6bhp). A test pass on a motorcycle meeting this specification gives direct access to any size of motorcycle. Driving tests taken on motorcycles with an automatic gearbox will restrict further driving as a full licence holder to motorcycles with similar transmission
B1	A motor powered tricycle or quadricycle capable of 60kph
B1	(Invalid Carriage) An invalid carriage
B	A four wheeled motor vehicle capable of 100kph
B+E	A combination of a category B test vehicle with a trailer weighing at least 1 tonne MAM, capable of 100kph
C1	A vehicle weighing at least 4 tonnes MAM and capable of at least 80kph
C1+E	A combination of a category C1 test vehicle with a trailer weighing at least 2 tonnes MAM and with a combined length of at least 8 metres, capable of 80kph
C	A rigid vehicle (not a tractive unit of an articulated vehicle) weighing at least 10 tonnes MAM and at least 7 metres in length, capable of 80kph



C+E	An articulated vehicle of at least 18 tonnes and 12 metres in length, capable of 80kph, or a combination of a category C test vehicle with a trailer weighing at least 4 tonnes MAM and 4 metres in length with a combined weight of at least 18 tonnes MAM and 12 metres in length, capable of 80kph
D1	A passenger carrying vehicle with between 9 and 16 passenger seats, capable of 80kph
D1+E	A combination of a category D1 test vehicle with trailer weighing at least 1.25 tonnes MAM, capable of 80kph
D	A passenger carrying vehicle with more than 8 passenger seats and at least 9 metres in length, capable of 80kph
D+E	A combination of a category D test vehicle with a trailer weighing at least 1.25 tonnes MAM, capable of 80kph
f	Any vehicle in category f
g	Any vehicle in category g
h	Any vehicle in category h
k	Any vehicle in category k
p	Any vehicle in category p

3. Minimum speed requirements

60kph	=	37.6mph
80kph	=	50mph
100kph	=	62.5mph

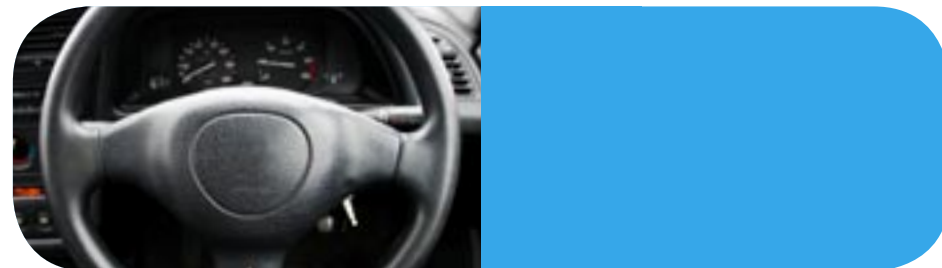
